Website Service Agreement

Before you can join MI NAHRO's Website Service ("the Service"), you must read and agree to the Subscriber Agreement and conditions set forth below. By joining this Service, you agree to be bound by the terms of this Agreement in their entirety. You must sign your name at the end of the Agreement. If you do not agree to be bound by the terms of the Agreement, you will not be able to proceed with the MI NAHRO Website Service registration process.

1. MI NAHRO Website Service

I hereby authorize MI NAHRO to enroll me in the MI NAHRO Website Service program. I understand the terms and conditions described below. I understand that this charge is a recurring charge every year. I authorize and instruct MI NAHRO to bill the amount of my yearly website service invoice to my housing commission/authority.

2. CUSTOMER INFORMATION

In consideration of my use the website service, I agree to: (a) provide true, accurate, current and complete information about my housing commission/authority and (b) maintain and promptly update the data to keep it true, accurate, current, and complete. If I provide any information that is untrue, inaccurate, not current, or incomplete, or if MI NAHRO has reasonable grounds to suspect that such information is untrue, inaccurate, not current, or incomplete, MI NAHRO retains the right to suspend or terminate my website service account and refuse any and all current or future use of the Service (or any portion thereof). Providing and maintaining accurate and complete data is my responsibility.

3. DOMAIN NAME FEE

I understand that a non-refundable DOMAIN NAME fee (typically between \$7 and \$20) will be assessed each year to my housing commission/authority. I agree to pay this fee, along with the applicable website service fee (\$200/year) for my website development and maintenance. I acknowledge that I have been given the option to procure my own domain name registration and therefore would have sole responsibility for renewing this registration every year.

4. TERMINATION

MI NAHRO may in its sole discretion and at any time discontinue providing the Service, or any part thereof and will notify me prior to such termination.

5. CANCELLATION

At any time, and for any reason, I may cancel my Service by electronic or conventional mail, or by telephone at the address and telephone numbers set forth in section 9 of this Agreement.

6. REFUNDS:

I understand that there will be no refunds issued for this service.

7. SEVERABILITY

If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any of this Agreement is invalid or unenforceable, but that by limiting such provision it would become valid or enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.

8. NOTICE

Notices by MI NAHRO to subscribers may be given by means of electronic messages through the site, by a general posting on the site, or by conventional mail.

Notices by subscribers may be given by electronic messages, conventional mail or telephone unless otherwise specified in the Agreement. All questions, complaints, or notices regarding website service must be directed here. All cancellations of Service must be directed to MI NAHRO as shown in section 9 of this Agreement.
